Privacy Policy

Your privacy is very important to us.

We commit to never disclosing your name or personal information to third parties.

PayPal Payment processes all of the transactions on Class Bake Sale No one sees your credit card information besides PayPal, not even us.

Email

Class Bake Sale pledges to only communicate with you when necessary, and otherwise only if and when you want to hear from us.

You will of course receive emails relating to your personal transactions. We will keep these emails to a minimum.

You will also receive notifications, for which there is an option to unsubscribe.

You may receive service-related announcements on the occasion that it is necessary to do so.

Campaign creators receive the email addresses of their backers if, and only if, the campaign is successfully funded.

Technology & Security

Class Bake Sale uses *cookies* to help recognize you anonymously as a repeat visitor and to track traffic patterns on our site. We use this information to make the Site more user-friendly.

We may obtain IP *addresses* from users. We will use this information only to monitor and prevent fraud, and diagnose problems.

This Site uses a variety of security measures, including encryption and

authentication tools. This is in attempt to maintain the confidentiality of your personal information. Your personal information is protected with firewalls and can only be accessed by a limited number of people under requirement to keep such data confidential.

Donations and funding is taken using a secure server. To the extent you select the secure server method and your browser supports such functionality, all credit card information you supply is transmitted via Secure Socket Layer (SSL) technology.

Despite our efforts, it is our obligation to inform you that no transmission of data over the World Wide Web can be guaranteed as 100% secure.

Voluntary Disclosure

If you voluntarily disclose any personal information or content, that content becomes available to the public and can be collected and used by other users. Please exercise caution before disclosing your personal information via public venues.

Campaigners

By entering into our User Agreement, Class Bake Sale Campaigners agree not to abuse other users' personal information. Abuse is defined as using personal information for any purpose other than those explicitly specified in the Campaigner's project, or is not related to fulfilling delivery of a product or service explicitly specified in the Campaigner's project.
